Privacy Policy

1. INFORMATION WE COLLECT

A. Information about You that You Provide.

SIA "2 Cloud", and/or its Service Providers (defined below), may collect information you provide directly to SIA "2 Cloud" and/or its Service Providers via or in connection with the Service. For example, SIA "2 Cloud" collects information when you use or register for the Service, subscribe to notifications, apply to qualify to become a customer, apply for or inquire about employment, or communicate or transact through or in connection with the Service. In addition, when you interact with Third-Party Services (defined below), you may be able to provide information to those third parties. For more information on Third-Party Services' data collection and practices.

Information SIA "2 Cloud", its Service Providers and/or Third-Party Services may collect may include: (1) personally identifiable information, which is information that identifies you personally, such as your first and last name, e-mail address, phone number, address, full payment account number, and Social Security Number (**"Personal Information"**); and (2) demographic information, such as your age, zip code, property size, and your interest in our products and services (**"Demographic Information"**). With regard to Social Security Numbers, it is our policy to protect the confidentiality of Social Security numbers in our possession from misuse and improper disclosure by maintaining and enforcing policies and physical and electronic safeguards against misuse and improper disclosure. Unlawful disclosure of Social Security numbers is prohibited, and access to them is limited to personnel who need access to such information in order to perform their business functions.

In addition, if you apply to become, or become, a customer of our Customer Services, you consent to our collection of information about your utility account (**"Utility Account Data"**) from your utility, and otherwise, which may include both Personal Information and utility account and usage data.

Except to the extent required by applicable law, Demographic Information is **"non-Personal Information"**(i.e., data that is not Personal Information under this Privacy Policy). In addition, Personal Information, including, without limitation and Utility Account Data. To the extent any non-Personal Information is combined by or on behalf of SIA "2 Cloud" with Personal Information SIA "2 Cloud" itself collects directly from you on or in connection with the

Service, or Utility Account Data we receive from your utility pursuant to your consent in connection with the Services.

B. Information Collected Automatically.

SIA "2 Cloud", its Service Providers, and/or Third-Party Services may also automatically collect certain information about you when you access or use the Online Services ("Site Usage Information"). Site Usage Information may include IP address, device identifier, browser type, operating system, information about your use of the Service, and data regarding network connected hardware (e.g., computer or mobile device). Except to the extent required by applicable law, or to the extent Site Usage Information is combined by or on behalf of SIA "2 Cloud", SIA "2 Cloud" does not consider Site Usage Information (including, without limitation, unique device identifiers) to be Personal Information more information on Third-Party Services' data collection and practices.

The methods that may be used on the Service to collect Site Usage Information include:

- Log Information: Log information is data about your use of the Service, such as IP address, browser type, Internet service provider, referring/exit pages, operating system, date/time stamps, and related data, and may be stored in log files.
- Information Collected by Cookies and Other Tracking Technologies: Cookies, web beacons (also known as "tracking pixels"), embedded scripts, and other tracking technologies now and hereafter developed ("Tracking Technologies") may be used to collect information about interactions with the Service or e-mails, including information about your browsing and purchasing behavior:
 - Cookies

A cookie is a small text file that is stored on a user's device, which may be session ID cookies or tracking cookies. Session cookies make it easier for you to navigate the Service and expire when you close your browser. Tracking cookies remain longer and help in understanding how you use the Service, and enhance your user experience. Cookies may remain on your hard drive for an extended period of time. If you use your browser's method of blocking or removing cookies, some but not all types of cookies may be deleted and/or blocked and as a result some features and functionalities of the Service may not work. A Flash cookie (or locally shared object) is a data file which may be

placed on a device via the Adobe Flash plug-in that may be built-in to or downloaded by you to your device.HTML5 cookies can be programmed through HTML5 local storage. Web Beacons ("Tracking Pixels")

Web beacons are small graphic images, also known as "Internet tags" or "clear gifs," embedded in web pages and e-mail messages. Web beacons may be used, without limitation, to count the number of visitors to the Service, to monitor how users navigate the Service, and to count content views.

Embedded Scripts

An embedded script is programming code designed to collect information about your interactions with the Service. It is temporarily downloaded onto your computer from SIA "2 Cloud"' web server, or from a third party with which SIA "2 Cloud" works, and is active only while you are connected to the Service, and deleted or deactivated thereafter.

SIA "2 Cloud" may also obtain information about you from other sources, including Service Providers and Third-Party Services, and combine that with SIA "2 Cloud" anything to the contrary, except to the extent such data is combined by or on behalf of SIA "2 Cloud", this Privacy Policy is not intended to limit SIA "2 Cloud" activities regarding such third-partysourced, or non-Service-sourced, information (including Personal Information), and such data will only be treated to the extend it is combined with. SIA "2 Cloud" is not responsible or liable for the accuracy of the information provided by third parties or for third party policies or practices.

2. HOW WE USE THE INFORMATION WE OBTAIN.

SIA "2 Cloud" may use information about you, including your Utility Account Data and other, as well as other Personal Information, for any purposes not inconsistent with SIA "2 Cloud"' statements under this Privacy Policy, or otherwise made by us in writing at the point of collection, and not prohibited by applicable law, including, without limitation, the following:

- Determine your eligibility to enroll in SIA "2 Cloud" programs;
- Contract with you for, and provide our solar management services to you;
- Allow you to participate in the features we offer on the Service;
- Facilitate, manage, personalize, and improve your Service experience;
- Process your application and/or registration and manage your account;
- Transact with you, provide services or information you request, respond to your comments, questions and requests, serve you content and/or advertising, and send you notices;
- SIA "2 Cloud" marketing and other purposes;
- Improve the Service and for any other internal business purposes;
- Tailor our content, advertisements, and offers;
- Fulfill other purposes disclosed at the time you provide Personal Information or otherwise where we are legally permitted or are required to do so; and
- Prevent and address fraud, breach of policies or terms, and threats or harm.

3. INFORMATION WE SHARE WITH THIRD PARTIES.

SIA "2 Cloud" may share non-Personal Information, and Personal Information that is not deemed SIA "2 Cloud" Collected PI hereunder (provided that SIA "2 Cloud" is aware of no restrictions of SIA "2 Cloud"' use, if any) with third parties for any purpose. However, SIA "2 Cloud"' sharing, including Utility Account Data, that has not been de-identified.

In addition, SIA "2 Cloud" may share your SIA "2 Cloud" Collected Personal Information (as well as your other Personal Information and your non-Personal Information), with our potential and current financiers and financial investors, and in connection with, or during due diligence or and negotiations of, any proposed or actual financing, merger, purchase, sale, joint venture, or any other type of acquisition or business combination of all or any portion of SIA "2 Cloud" assets, or transfer of all or a portion of SIA "2 Cloud" business to another company (**"Corporate Transactions"**), provided.

4. THIRD-PARTY CONTENT, THIRD-PARTY SERVICES, SOCIAL FEATURES, ADVERTISING AND ANALYTICS.

The Online Services may include hyperlinks to, or include on or in connection with the Online Services (e.g., plug-ins), websites, locations, platforms, applications or services operated by third parties (**"Third-Party Service(s)"**). These Third-Party Services may use their own cookies, web beacons, and other Tracking Technology to independently collect information about you and may solicit Personal Information from you.

Otherwise, the information collected, stored, and shared by third parties remains subject to their privacy policies and practices, including whether they continue to share information with SIA "2 Cloud", the types of information shared, and your choices on what is visible to others on Third-Party Services.

SIA "2 Cloud" is not responsible for, and makes no representations regarding, the policies or business practices of any third parties, including, without limitation, analytics Service Providers and Third-Party Services associated with the Service, and encourages you to familiarize yourself with and consult their privacy policies and terms of use.

5. DATA SECURITY AND MONITORING.

SIA "2 Cloud" takes reasonable measures to protect from loss, theft, misuse and unauthorized access, disclosure, alteration, and destruction. Nevertheless, transmission via the internet and online digital storage are not completely secure and SIA "2 Cloud" does not guarantee the security of your information.

To help protect you and others, SIA "2 Cloud" and its Service Providers may (but make no commitment to) monitor use of the Service, and may collect and use related information including SIA "2 Cloud" Collected PI and other Personal Information for all purposes not prohibited by applicable law or inconsistent with this Privacy Policy, including, without limitation, to identify fraudulent activities and transactions; prevent abuse of and investigate and/or seek prosecution for any potential threats to or misuse of the Service. Monitoring may result in the collection, recording, and analysis of online activity or communications through our Online Services. If you do not consent to these conditions, you must discontinue your use of the Online Services.

6. CHILDREN'S PRIVACY.

The Service is intended for an audience 18 years of age and older. Accordingly, SIA "2 Cloud" does not intend to collect personal information. If we obtain knowledge that we have collected Children's Personal Information

7. ACCESSING AND CHANGING INFORMATION.

SIA "2 Cloud" may provide web pages or other mechanisms allowing you to delete, correct, and potentially certain other information about you (e.g., account information). 8. CHOICES: TRACKING AND COMMUNICATIONS OPTIONS.

A. Tracking Technologies Generally.

Regular cookies may generally be disabled or removed by tools available as part of most commercial browsers, and in some instances blocked in the future by selecting certain settings. Browsers offer different functionalities and options so you may need to set them separately. Also, tools from commercial browsers may not be effective with regard to Flash cookies (also known as locally shared objects), HTML5 cookies, or other Tracking
